### ORDER

(DETERMINING SEATS FOR GRAM PANCHAYATS AND RESERVATION OF SEATS FOR OFFICES OF PRADHANS FOR WOMEN)

No. 3-12/Pench/D-Cell/2015/4360

Port Blair, dated the 30th May, 2015

WHEREAS, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, vide Notification No. 90/2015, dated 30th May, 2015 constituted a Gram Sabha for each village specified by him vide Notification No. 89/2015, dated 30th May, 2015;

AND, WHEREAS, under Sub-Section (2) of Section 11, read with Sub-Section (1) ibid of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994 (No. 1 of 1994), it is required to determine the number of seats to be filled by direct election by each Grant Sabha to form an Executive Committee called the Gram Panchayat and to elect a Chairperson called the Pradhan;

NOW, THEREFORE, as required under the said Section of the said Regulation, the undersigned in supersession of the Order Notified in the Extraordinary Gazette No. 74, dated 28th April, 2015, hereby determine the number of seats in each Gram Panichayat as detailed in the Schedule below:

In terms of provision (b) to Sub-Section (9) of Section 11 of the said Regulation, it is further ordered that 10 seats out of total 30 seats for offices of Pradhan in the Gram Panchayats shall be reserved for women and the seats so reserved shall be allotted by the Election Commission by rotation in such manner as provided for in the rules made under the said Regulation.

It is further provided that there shall be no reservation of seats for Scheduled Tribes and for Women belonging to Scheduled Tribes for the offices of Pradhan in terms of Subantion (5) and (6) of Section 11 of the said Regulation, as their total population is less than half the proportionate population required to fill one seat, in any Gram Panchayat.
