ORDER

Port Blair, dated the 14th July, 2015

(DETERMINING SEATS OF PRAMUKHS FOR WOMEN IN PANCHAYAT SAMITIES)

F.No.3-5/Panch/D-Cell/2014.— WHEREAS, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, had constituted seven Blocks for the purpose of Panchayat Samities constituted a Samiti each for each Block and also notified the number of seats in each Samiti vide Notification No.35/95/F.No.3-2/94-PR/PS dated 1/3/1995, No. 36/95/F.No.3-2/94-PR/PS dated 2/3/1995 and No. 77/2015/F.No.3-1/2015/PR/GP dated 12/05/2015 respectively.

AND, WHEREAS, it is required to reserve seats of Pramukhs for Women in all the Panchayat Samities in terms of Sub-Section (5)(b) of Section 112 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994.

AND, WHEREAS, the Deputy Commissioner, South Andaman District determined the seats of Pramukhs for Women in Panchayat Samities of South Andaman District vide Order No.3-5/Panch/D-Cell/2014, dated 26th May, 2015 and published in the Extra Ordinary Gazette No. 91, dated 26th May, 2015.

AND, WHEREAS, the Deputy Commissioner, Nicobar District determined the seats of Pramukhs for Women in Panchayat Samiti, Campbell Bay of Nicobar District vide Order No.1-8/DCN/Panchayat Election/C/Bay/2015 dated 26th May, 2015 and published in the Extra Ordinary Gazette No. 92, dated 26th May, 2015.

AND, WHEREAS, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands vide Notification No.127/2015 dated 13th July, 2015, changed the Jurisdiction of the Deputy Commissioner, South Andaman District.

NOW, THEREFORE, in supersession of the Orders published in the Extraordinary Gazette No 91 & 92 dated 26th May, 2015, it is hereby ordered that there shall be reserved two (2) seats in the office of Pramukh for Women out of four (4) seats in South Andaman District and Campbell Bay (Nicobar District) which shall be allotted by the Election Commission in the manner prescribed in the Andaman and Nicobar Islands (Panchayats) (Preparation of Electoral Roll and Conduct of Elections) Rules, 1995.
