No. 5-29/EC/A&N/2015: Whereas, the proposals for delimitation of twenty four wards of Port Blair Municipal Council (PBMC) were published in the Official Gazette vide Notification No. 5-29/EC/A&N/2015 dated 5th March, 2015 inviting suggestions and objections by 23rd March, 2015 in compliance with Rule 5 (1), 5 (2) and 6 (1) of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995;

And, whereas, suggestions and objections received before the specified date have been considered by the Election Commission appointed under Section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994;

And, whereas, opportunity of a public hearing has been granted to all persons who made suggestions and objections including representatives of political parties in an open meeting at Dr. B.R. Ambedkar Auditorium (DBRAIT), Pahargaon, Port Blair on 22nd April, 2015;

Now, therefore, in pursuance of Section 9 (1) and Section 33 of the Andaman and Nicobar Islands (Municipal) Regulation, 1994, read with Rule 5 and 6 (2) the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995, the Election Commission for the Union Territory of the Andaman & Nicobar Islands, after consideration of all the suggestions and objections received and taken up in the aforementioned public hearing, hereby determines the delimitation of the wards of Port Blair Municipal Council as detailed in Annex-I appended to this order and publishes the same in the Official Gazette;

A detailed map showing the extent of each ward of PBMC is included as Annex-II.

The summary of suggestions and objections received in response to the Election Commission's proposals for delimitation of wards of PBMC alongwith the Election Commission's comments/observations thereon is enclosed as Annex-III.

Final Order of Election Commission on delimitation of wards of PBMC for the forthcoming Election

Draft delimitation proposals in respect of Port Blair Municipal Council with 24 wards were notified on 05.03.2015 by the Election Commission in exercise of powers under Section 9(1) and Section 33 (1) of the Andaman and Nicobar Islands (Municipal) Regulation, 1994 read with Rule 5 & 6 of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995. Suggestions and Objections were invited upto 23.03.2015.

In all, twenty four objections and suggestions from various persons and political parties were received by the due date. All the objections and suggestions received have been duly considered by the Election Commission which has been assisted by a Delimitation Committee.

Many of the persons/political parties have suggested, inter alia, to retain old ward numbers from 1 to 18 of the PBMC and to give ward numbers from 19 to 24 to the new areas included in the PBMC so that there is no change in the address for people living in the erstwhile wards.

Relevant provisions on delimitation are Section 9(1) and Section 33 (1) of the Andaman and Nicobar Islands (Municipal) Regulation, 1994 and Rule 5 of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995 which are reproduced below:

Section 9(1) of the Andaman and Nicobar Islands (Municipal) Regulation, 1994 provides that 'the Election Commission shall divide the municipal area into territorial constituencies in such manner that the ratio between the population of each ward and the number of seats allotted to it shall so far as practicable, be the same throughout the municipal area'.

Section 33(1) of the Andaman and Nicobar Islands (Municipal) Regulation, 1994 states that 'for the purposes of election to a Municipality every municipal area shall be divided into single member wards in such manner that the population of each ward shall, so far as practicable, be the same throughout the municipal area'.

Rule 5 (1) of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995 provides that 'as soon as may be after the Notification determining the number of seats in the Municipal Council under Rule 4 by the Administration is issued, the Commission shall divide the municipal area into wards in the manner prescribed in Sub-Section (1) of Section 9'.

Sub-rule (2) of Rule 5 of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995 states that 'the area included in each ward shall, as far as practicable, be geographically compact and in delimiting it regard shall be had to physical features, existing boundaries of administrative units, facilities of communication, public convenience, and such other factors as the Commission may think fit'.

In the existing Municipal Council there are 18 wards and the population wardwise ranges from 3910 to 10,675. Fresh delimitation has to be done (i) as per the 2011 Census on account of wide variation in population (ii) increase in municipal area after the addition of six revenue villages vide Notification No.3-195/2013-UD dated 10.12.2014 and (iii) increase in the number of seats from 18 to 24 notified on 02.01.2015 by the Administrator. The last delimitation of PBMC was done in 1995.

In the public meeting held by the Election Commissioner on 22nd April, 2015, ample opportunity was extended to the persons who had submitted his/her suggestions and objections to the draft delimitation proposals, as well as to the representatives of political parties present in the meeting to express their views in support of their representations.

After due consideration of the suggestions, the Election Commission modifies its Notification of draft proposals for the delimitation of wards to the extent possible and practicable and hereby orders the final delimitation of twenty four wards of PBMC as detailed in Annex-I which is also depicted on the map with boundaries explained in the text. Since most of the ward boundaries have changed their numbering has been done in seriatim as followed by Survey of India.

ANNEXE - I

WARD NO. 1

(Population : 6580)

The ward boundary starts from the New Vehicle Ferry Jetty, along the main road upto Chhatrapati Shivaji Maharaj Police Station and reaches Hotel Dream Palace covering old WIMCO factory, Forest Club. The boundary then travels along the road leading from Husain Pan Shop and reaches the Road Jn. Opp. Haddo Health Centre, Haddo. Further the boundary extends upto Hotel Driftwood, along the Haddo road covering Hotel Hilltop and reaches Panipat Road Jn. and the boundary travels along the road covering Naval Store upto approach road to IOC in the West and then turns towards the junction in front of P.S. Chatham and ends at the New Vehicle Ferry Jetty, Chatham.

WARD NO. 2

(Population : 6437)

The Ward boundary starts from Chatham Island covering the entire Chatham Island and goes over the Chatham bridge, reaches the road junction in front of P.S. Chatham, further extends towards Southeast along the foreshore road by covering Inland Marine Workshop, Hotel Baobab covering entire land on seaward side and reaches Foreshore-Megapode Nest Jn. The boundary then extends along the road leading to Megapode Nest covering CARI Office, Directorate of Agriculture Office and reaches the main road junction in front of Rajya Sainik Board (opposite to AAI Office) again it extends on the main road covering Hotel Driftwood, Haddo School, Mini Zoo and reaches Haddo Urban Health Centre Jn. then extends towards west along Laltha Singh ground and reaches PBMC Ratri Niwas covering Sree Kollapuri Bhavani Temple, reaches Hotel Dream Palace and from thereon the boundary goes towards P.S. Chatham and ends at the Chatham Island.

WARD NO. 3

(Population : 5805)

The Ward boundary starts from the road junction in front of Rajya Sainik Board and goes along the Megapode Road covering Govt. Qtrs on the right side and reaches the Megapode Foreshore Road Jn. and then the boundary extends along the seashore covering office of PMB, Phoenix Bay Jetty, passes through the Fisheries Jetty covering all jetties and reaches the road opposite to Transport Office and the boundary extends towards Power House Jn., goes along the road upto LIC Jn. covering Govt. Petrol Pump, Syndicate Bank, thereon the boundary extends along the LIC-Delanipur road and reaches Delanipur Jn. covering Tamizhar Sangam, Samajam, and reaches Delanipur Jn. Then the boundary travels towards AIR and extends North along the road towards Buniyadabad Water Tank covering Municipal Qtr. Dr. Shankar's house, Municipal Water Supply Site Office and reaches the Jn. Opp. Hotel Driftwood and goes further few distance towards Southeast and ends at Rajya Sainik Board.

WARD No.4

(Population : 5805)

The Ward boundary starts from Phoenix Bay Power House Jn. and goes along the Phoenix Bay Jetty road (opp. DSS Office) and travels along the coast towards the fencing of Marine Dock Complex, covering entire Marine Dockyard, further Choulanga Jetty, CARI Office, Fishery Resort Bay Island, and reaches Fish Landing Jetty at Dugnabad, and towards Dugnabad S. The boundary extends upto Jama Masjid covering Round Basthi and connects the road at Y-Narayan Jn. from there the boundary goes towards West along the main road covering Clock Tower, Bakery, Ganesh Temple, reaches at Gandhi Statue Jn., extends along the main road upto LIC Jn. covering PBMC Head Office, and turns North, extends upto Power House Jn. covering Municipal Auditorium, SAD Office, Electricity Office, Directorate of Fisheries and ends at Power House Jn.

WARD NO. 5

(Population : 6330)

The Ward boundary starts from LIC Jn. extends to Gandhi Statue covering Jadwet Petrol Pump, SBI, and goes towards Clock Tower covering Tiranga Park, Ratnam Market, Hotel Mills. The boundary travels Northwest connecting Y-Narayan Jn. and turn west towards the Jama Masjid and then along Dugnabad road, reach the Fish Landing Jetty at Dugnabad Foreshore covering Municipal Jewellery, Dy. S.P. Shaukat's house, thereon the boundary extends towards Northeast reaching Rajiv Gandhi Water Sports Complex covering G.B. Pant Hospital, Fisheries Cold Storage, Fish Aquarium and travels along the Sea Wall at Rajiv Gandhi Water Sports Complex, Marina Park covering whole of Water Sports Complex, Marina Park. Further it extends towards Rama Krishna

Mission Jn. and turns South, along the road leading to Dr. Wazid Ali's house, and passes towards West along the RGT road and reaches the Murugan Temple Jn., further the boundary goes along the road on West leading to Raj Niwas junction, passes CAT building Jn. extends to Model School traffic junction (old Library) covering, Raj Niwas, MP Bhawan, further the boundary goes West towards Bengali Club (Atul Smriti Samity) covering entire Model School, Gurudwara Lane, Biggie Lane and then extends Northwest along the main road upto LIC Jn. covering Hindi Sahitya Kala Parishad, Old Light House Cinema and ends.

WARD NO. 6

(Population : 5714)

The boundary starts from Delanipur Jn. travels towards east covering New Anumod Bakery, TSG Hotel, Hotel Haywizz, Hotel Velocity, entire Phongy Chaung and reaches LIC Jn. covering the entire portion on the right side, thereafter the boundary leads to Bengali Club Jn. covering A & N State Cooperative Bank, APWD Head Office, then the boundary goes along the road upto Model School Jn. covering Head Post Office, Old Library and travels further South East covering CAT building and from there the boundary goes along the road upto DC Office Jn. covering Indian Airlines Office, the boundary further travels upto the Secretariat Jn. covering Anthropological Building on the right and goes along the link road covering DIET Building, APWD Site Office and reaches Goalghar Jn. From Goalghar Jn. the boundary travels on South upto Junglighat School Jn. covering the entire portion on the right side, the boundary travel west along the Shamshan Ghat road covering Ashim Bhattacharaya Park, entire Goalghar Colony and from Burning Ghat the boundary goes along the Prem Nagar Kali Mandir and reaches Kali-Mandir and thereon the boundary connects to the road behind Councillor Colony and extends upto Shri. J.M. Anthony's house and goes along the road on North upto Telugu Baptist Church and then the boundary travels along the footpath upto Balan's House covering Palani's House and N. Mary's house and reaches Chirayu in-patient ward, extends toward Hotel Andaman Residency covering the entire Govt. Qtr. Junlighat Hospital and then boundary travels along Goalghar - Delanipur Road covering Nirmala School, Chevrolet Showroom and ends, at Delanipur Jn.

WARD NO. 7

(Population :5736)

The Ward boundary starts from the road Jn. opposite Dr.Rohin's Eye Hospital, extends towards Delanipur Jn. covering Hotel Classic Regency, Delanipur Community Hall. Then the boundary goes along Delanipur-Goalghar road and reaches Hotel Andaman Residency covering Dawaat Restaurant, Uma Bakery, thereon the boundary travels South and reaches Chirayu in-patient ward and connects to the footpath near Balan's House and extends upto Telugu Baptist Church covering open stage, PBMC Barrack and thereafter the boundary extends towards south alongwith the road upto J.M. Anthony's house and reaches Prem Nagar Kali Mandir. Further the boundary extends to the Shamshan Ghat at Junglighat and passes along the sea shore road, upto ISPW fencing then the boundary goes upwards along the fencing and reaches the road leading to the office of the A.E, PBMC (behind AIR) then boundary extends towards AIR gate along the road and ends road Jn. Opp. Dr. Rohin's Eye Hospital.

WARD NO. 8

(Population : 5416)

The boundary starts from IOC road Jn. at Panipath road and the boundary travels towards Southeast and reaches upto Old Dhanvantri Jn. (opp.) Hotel Driftwood and then the boundary travels towards South towards Buniyadabad covering the entire portion on the right side and reaches the road Jn. opposite Dr. Rohin's Eye Hospital and goes towards All India Radio Road covering the entire portion on right side and reaches upto the road leading to office of the Assistant Engineer (PBMC) and thereafter travel towards South West along the ISPW fencing and reaches upto sea shore and then the boundary travels along the coast and goes towards North covering Naval Jetty and reach upto the IOC road Jn. and ends.

WARD NO.9

(Population :6721)

The boundary starts from Choudhary Mill Jn., travels towards east, reaches Junglighat School Jn. the boundary then travels South along the Junglighat main road encompassing Junglighat Radha Krishna Mandir, Honda Showroom, Icy Spicy building, reaches Hayat Singh's Jn. from thereon the boundary goes further towards ITF Ground and travels along the road leading to Helipad and connects to the runway and travel upto INS Utkrosh Gate along the runway including the width of runway covering Air Terminal building, Hotel Nagri Inn, Pillar Hospital,

Citizen Colony, VKV School, SBI, Rakshavihar Branch, and reaches the road jn. opposite Utkrosh gate and then the boundary travels west towards APWD Treatment Plant Complex covering entire portion on the right side and travels upto the CPWD Complex, General pool accommodation, PBMC Civic public convenience and reaches Dairy Farm Milk Plant and then the boundary travels along road opposite Ganesh Mandir (behind Dairy Farm School) reaches the CC Footpath and extends upto the sea shore road at lower Dairy Farm, from there the boundary travels towards east along the coast including the road, the seaward side land, Municipal Chicken market, Junglighat New Jetty Complex, Vegetable Market, Fish market and then reaches upto Choudhary Mill Jn. and ends.

WARD NO. 10

(Population : 5751)

The ward boundary of Ward No. 10 starts from CAT Building Jn. and goes along the road leading to DC Office Jn. And extend towards RBV School covering District Court, Secretariat, Zilla-Parishad Office goes further South-west towards Hawa Ghar Jn. covering Joggers Park. From Hawa Ghar Jn. the boundary turns East and reaches Dudh Line Jn. and extend towards the road leading to Shadipur Jn. covering Metrological Office and reaches Shadipur Jn. Further it goes along the road leading to Civil Wireless Qtrs. and goes towards South Point covering South Point Water Tank, Municipal Qtrs., entire area on the left and reaches Hotel Sinclairs Jn. Further it extends Northeast goes along the road upto Ayyannar Temple covering Nicobari Guest house and the boundary goes along the walkway covering Govt. Press, JNRM, entire area on the left and reaches Ramakrishna Mission Trijunction. The boundary then goes along RGT Road and reaches the CAT Building Jn. covering, Machi Line, Radha Govind Temple, Murugan Temple, Gandhi Park and ends at CAT Building Jn.

WARD NO. 11

(Population : 5476)

The boundary starts from the road opposite Metrological Office and travels along North-east and reaches upto Shadipur School Jn. covering the entire portion on the right side, Shadipur School and further goes upto Shadipur CCS along the road and extends upto Civil Wireless covering Rishika Store, temple, and further goes towards South Point covering the mosque and leads towards Hotel Sinclair Jn. and extends upto Ayyannar Temple, Sinclairs Hotel and travels west along the walkway covering Ayyannar Temple, Sinclairs Hotel and reaches upto Mazhar Pahar covering the entire portion on the right side and it goes along the natural nallah and reach opposite Met Office and the boundary ends.

WARD NO. 12

(Population : 5206)

The Ward boundary starts from the road Jn. opposite Metrological Office travels alongwith natural nallah and reaches upto the Corbyns Cove road near Mazhar from there the boundary travels Southeast covering Judges Bungalow, Science Center, Hornbill Nest and goes on West from the Bunker Jn. and reaches ATI Guest House behind Sarovar Portico Resort (Peerless Resort) and thereafter the boundary goes upwards on the link road and reaches the Chakkargaon Road near children's Park, boundary travels South-west covering Type - V accommodation, Police Qtr. fisheries colony, part of Nayagaon Basthi and entire Doctor Colony, further the boundary goes along the link road and connects to the compound wall of Chakkargaon Digi and connects the road behind ATC tower and goes along the runway excluding the runway width and then gets connected to the footpath extends further Northeast to the Bahadur Lane Link road, and connects to Joggers Park road and from there it goes upto the Hawaghar Jn. and further travels towards Maruti Service Station and from that Jn. the boundary gets connected to the Metrological Office Jn. and ends

WARD NO. 13

(Population : 5297)

The Ward Boundary of Ward No. 13 starts from Secretariat Jn. leading upto RBV School Jn. covering the settlement on the right side including Zilla Parishad Niwas and passes towards South covering Chinamaya Mission, Police Qtrs. Police Line and reaches upto Joggers Park and further passes a few meters and then take right downward west upto Bahadur lane road and connects to the footpath covering the new Police Qtrs. and the entire private houses falling on the right side and connects airfield/ runway including width of runway then travels along the runway and then reaches upto the Helipad Complex covering the entire area on the right side and

the boundary travels towards VIP Road covering Helipad and ITF Ground, extends towards South West upto Hayat Singh Jn. and passes towards North on Junglighat main road covering Goenka Showroom, old CCS, Islands Bakery Jn. and the boundary further travels towards Goalghar Jn. covering the entire Junglighat upper area, Hotel Silver Spring, ANIIDCO Petrol Bunk and the boundary travels towards east on Link road covering Veterinary Hospital, NABARD Colony, Anti-Corruption Office and reaches the Secretariat Jn. and ends.

WARD.14

(Population : 6575)

The Ward boundary starts from the seashore near Tirupathi Temple travels along the coast covering the entire stretch of Dairy Farm area, extends further north east covering the fisherman settlement, Hanuman Temple, Fish Landing Jetty, Ram Mandir covering the entire portion on the seaward side of the road and reaches upto G. Srinu's house, then it goes south along footpath covering the entire portion on the right side and reaches upto the road behind Dairy Farm School, from there on the boundary leads upto the milk plant junction and extends further west along the Dairy Farm road, Ganesh Temple covering Municipal Shops and goes along the footpath opposite Shri Surendaran's house upto Pottaiah's house and reaches Japan road covering the entire portion on right side, thereafter the boundary travels towards south along the CC footpath upto Nokamma's house and connects the CC drain and then the boundary travels along the nallah and ends at seashore near Tirupathi Temple.

WARD NO.15

(Population :5978)

The Ward boundary starts from Dairy Farm Milk Plant Junction, goes along the south upto Nagarpalika VKV School, covering Jawahar Sarovar, Forest Nursery and further travels towards APWD Treatment Plant covering the entire portion on the right side and reaches the main road opposite Utkrosh Gate and travels along the internal road of Utkrosh upto Runway including the width of runway, then the boundary travels upto drain at School Line Jn. opposite Uma Bakery covering entire portion on the right side, and then the boundary travels towards north-west upto Andaman Housing Society road junction and extends upto Jawahar Colony and covering entire Ranchi Tekri, right side of Jawahar Colony, Marine Qtr. reaches upto the compound wall of defence on the left and travels along the compound wall covering the entire Govt. Qtrs. on the right and connects to the compound wall of Jawahar Sarowar and reaches upto CC drain opposite Saraswathi's house and thereafter travels along CC footpath and connects to the Japan Road covering the entire upper Dairy Farm area on the right side and goes towards south along the CC footpath upto Surendaran's house covering Shiv Mandir, Vegetable market and reaches Dairy Farm road and ends opposite Milk Plant Junction.

WARD NO. 16

(Population : 6277)

The ward boundary starts from ATR road opposite Hotel Magpie Residency and travels along the road through Lokenath Colony and moves north-west connecting to the road leading to Govt. Polytechnic and travels further on the same road connects to old Pahargaon road towards Maakali Garage and travels west upto a culvert in front BRAIT Auditorium and the boundary travels along the nallah and reaches upto Minni Bay road along the fencing opposite Gurudwara and then goes upto Dhanwantri covering D&K City, Friend's Housing Society, Vatika Park, Dhanwantri Hospital and thereafter the boundary turn to north-west and reaches sea shore and travels along the sea shore and reaches the ATR -Dollygunj road Jn. near Shiv Mandir (opp. pond) and travels along the ATR and ends at Hotel Magpie Residency.

WARD NO. 17

(Population : 5880)

The boundary starts from ATR road opposite Hotel Magpie Residency and travels Southwest along the ATR upto Shiv Mandir Jn. (opp. pond) and then the boundary travels North along the Dollygunj road, covering the entire area on the right side, and reaches upto Mini stadium, toward south along the road upto Balikanekatan Jn. Covering Central Hatchery Unit, Poultry Farm and passes along the revenue boundary of Dollygunj village covering Sita Nagar Colony upto Plot No. 1/p near Sea shore. Thereafter the boundary travels upto Dhanwantri Hospital Jn. along the shore and extends upto Gurudwara Covering Minni Bay, Sri Nagar colony, Ajay Baugh, Pushpa Market and travels south-west along the nallah and reaches upto the culvert in front of Maakali Garage and connects to old Pahargaon road covering the entire portion on the right including BRAIT Auditorium and passes through the Lokenath Colony and connects to ATR next to Hotel Magpie Residency and the boundary ends.

WARD NO. 18

(Population : 5698)

The boundary starts from Balika Niketan tri-junction and goes along the road on southern side covering the entire portion on the right side and reaches Bus Stand (Shiv Mandir) junction. Garacharma then it takes right and moves along the road towards the Primary Health Centre Garacharma and reaches APWD Pump House and turns south-west along the road (Garacharma village boundary). Then the boundary turns west and reaches APWD Water Treatment Plant and travels along the compound wall of treatment plant and connects to the compound wall of T behind Aurbindo Hostel and extends towards Police Station covering Police qtrs. and connects the road (leading to Teylerabad) and the boundary extends along the revenue boundary Garacharma village (between Sumangalam's factory and Shri. Maula Ali's house) and travels along the revenue boundary covering Garacharma Basthi, Atom Pahad, along the coast and reaches upto Plot No. 1/p and connects to road and travels along the road to Balika Niketan J via Sita Nagar covering entire area on the right side.

WARD NO. 19

(Population : 6135)
