
Subject: - Result of Bye Elections to casual vacancies in PRIs - reg.

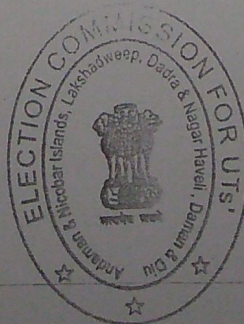



And, whereas, the poll was taken on 20th January, 2019;

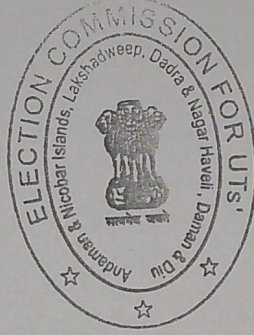
And, whereas, after the counting of votes on 21st January, 2019, the Returning Officers have declared the result of the election;
